

**“Fallon Flyaway”
Official Contest Rules**

1. **Dates/Eligibility.** The Bonneville Broadcast Group Fallon Flyaway Contest (the “Contest”) begins at 4am (MT) October 30, 2017 and ends November 3, 2017 at 10:30pm (MT). KSL and Utah’s Classic 103.5 The Arrow (the “Stations”) may change the dates or terms of the Contest without prior notice. Any material changes will be posted on a page at www.1035thearrow.com (the “Sites”). The Contest is open to all legal residents of Utah, eighteen (18) years of age and older at the time of entry. There is no purchase necessary to enter or win. A purchase will not increase a contestant’s chance of winning. The Contest is void where prohibited by law. Employees or agents of the Station, Bonneville International Corporation, and any entity associated with the sponsorship or administration of the Contest (collectively, the “Sponsors”) or any other television or radio station that transmits a signal for reception anywhere within the State of Utah, as well as members of the same household of the employee or agent, are ineligible to participate.
2. **How to Enter.** Enter the contest by visiting www.1035tharrow.com or www.facebook.ksltv.com. Additionally, viewers and listeners can listen to Jon Carter weekdays at 8:45am for the daily keyword to earn bonus entries. Viewers can also watch KSL News at 10pm for additional keywords and bonus entries. Viewers will be able to enter one (1) time for each correct keyword. Viewers will be granted fifty (50) bonus entries for each correct keyword. By entering the contest participant agrees to strictly adhere to the Contest rules and understands that they are subject to disqualification for non-compliance with these rules.
3. **Selection of Winner.** On November 3, 2017, one (1) finalist will be selected at random to win the Flyaway for two to see The Late Show with Jimmy Fallon live in New York on February 7, 2018 (date subject to change). The Station will announce the name of the winner on KSL 5 News at 10:00pm on Friday, November 3, 2017. The Station will attempt to contact the winner as soon as possible using the information provided on the entry form. If the Station is unable to contact the winner by Friday, December 1, 2017 the station will choose an alternate winner. If the winner is unable to use their prize the Station will select an alternate winner
4. **Prize and Manufacturer's Suggested Retail Price ("MSRP"):** Grand Prize (1): The Grand Prize winner will win roundtrip airfare for two from Salt Lake City to New York, , two (2) tickets to the Late Show with Jimmy Fallon on February 7, 2018 and two (2) nights hotel accommodations (up to \$500). Winner must personally sign for prize by December 5, 2017 or the prize will be forfeited. The total value of the Grand Prize is \$1,500 which includes sales tax and licensing.

Ground transportation is not included in prize package. All sales, prize and other taxes, gratuities and any other incidentals associated with the prize are the sole responsibility of the prize winner. Certain restrictions shall apply to the Vacation Packages, which restrictions shall be determined by KSL TV in its sole and absolute discretion. Each winner and his/her guests must travel together on the same itinerary. The Vacation Packages shall not include the following: baggage fees, travel insurance, hotel room service, parking fees, laundry service, food, alcoholic beverages, merchandise, souvenirs, etc., local and long distance telephone calls, tips, gratuities, service charges, resort fees or taxes, or all other charges not explicitly included in the packages pursuant to the Vacation Packages. The Vacation Packages (and all elements thereof) may not be sold, redeemed for cash, traded, transferred, or rescheduled except in KSL’s sole and absolute discretion. The Vacation Package may not be sold or transferred to any other person or third party. The Stations assume no responsibility or liability for damages loss or injury resulting from acceptance or use of the prize. The Stations reserve the right to substitute a prize or any component of a prize with a prize or component of comparable value should the original prize or component be unavailable, regardless of reason. The Stations, in its sole discretion, may award prizes to entries received by alternate means. Decisions of the Stations/Judges are final. Winner must produce identification satisfactory to the Contest Sponsor prior to being awarded Prizes.

5. **Conditions/Restrictions.** In exchange for the right to participate in the Contest, each contestant agrees to release and indemnify each of the Sponsors, and the officers, directors, agents, parent companies, subsidiaries and employees of each of the Sponsors, for, from and against any and all claims, demands and causes of action of any nature or kind whatsoever, whether presently known or unknown, foreseen or unforeseen, that arise out of the contestant’s participation in the Contest. Entry into the Contest constitutes permission for each Sponsor and its designees to use the contestant’s name, likeness, portrait, voice and biographical material for an unlimited period of time in order to advertise, promote or publicize the Sponsor or the products and services of any of its designees or both. Winner will be required to produce identification satisfactory to the Station and sign an affidavit of eligibility and a release (including a publicity release) as prepared by the Station. Anyone using fraudulent means to participate in or win the Contest will be subject to disqualification. The Sponsors are not responsible for technical, hardware, software or telephone or other transmission failures of any kind, lost or unavailable network connections or incomplete, garbled or delayed computer transmissions, regardless of cause. The Station reserves the right in its sole discretion to cancel or suspend the Contest should a virus, bug or other problem beyond the control of the Station corrupt the administration, security or proper execution of the Contest.
