- a. These rules govern the Band of the Day \$2K Giveaway ("Contest"), which is being conducted by KRSP-FM ("Station"). The Contest begins on January 4, 2021 and ends on January 29, 2021 ("Contest Dates"). Entrants, as defined below, may enter on-air only.
- b. To enter the Contest, the person entering the Contest ("Entrant") may enter on-air beginning on January 4, 2021 at 7:00 a.m. (MST) and ending on January 29, 2021 at 5:10 p.m. (MST) ("Entry Period").
  - To enter on-air, listen to the Station each weekday beginning on January 4, 2021 at 7:00 a.m. (MST) and ending on January 29, 2021 at 5:10 p.m. (MST) during these dates (except for holidays) and listen for the on-air personality to announce the band of the day to be listening for. Upon hearing the band of the day, the fifteenth (15th) designated caller (as announced by the on-air personality prior to the cue to call) to get through to the Station Contest line: (801) 575-1035, will win a qualifying prize ("Qualifying Prize Winners") upon confirmation of eligibility, and will be qualified for a chance to win a grand prize ("Grand Prize Winner") upon confirmation of eligibility. The grand prize will be announced each Friday during the Entry Period (January 8, 2021, January 15, 2021, January 22, 2021, and January 29, 2021) at 5:10 p.m. (MST). At the time of Entrant's call, Entrant will be required to provide all information requested including Entrant's full name, complete address (including zip code), day and evening phone numbers, email address, Social Security Number, and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the Contest line and completes the call will be a Qualifying Prize Winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a Qualifying Prize Winner or Grand Prize Winner only once during the

The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (i) any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) any immediate family members of such employees, including, without limitation, current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) any other individual legally residing in the same household (i.e., at the same address) of such employees, including, without limitation, roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to entering the current Contest are not eligible to participate. - d. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address; or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest.
