

The following "CONTEST" is intended for participants in the United States only and will be governed by United States laws. 1. HOW TO ENTER

a. The following are the ways to enter the "CONTEST": on the Arrow App or on-air beginning JANUARY 13, 2025 at 12:01 AM (MT) and ending on JANUARY 26, 2025 at 11:59 PM (MT) ("Entry Period").

- i. "Entrant" may enter online at <https://www.1035thearrow.com> beginning January 13, 2025 at 12:01AM MT and ending on January 26, 2025 at 11:59PM MT, -or-
- ii. "Entrant" may enter on the Arrow App beginning January 13, 2025 at 12:01AM MT and ending on January 26, 2025 at 11:59PM MT. Download the 103.5 The Arrow App from the iTunes App Store or Google Play Store or this link: <https://1035thearrow.com/mobile/>, -or-
- iii. "Entrant" may enter on-air starting on January 21, 2025 and ending on January 24, 2025. During this entry period listen to 103.5 The Arrow at 7am for Smith & Sam to announce the song to listen for. That song can play anytime the same day it's announced between 6AM MT and 6PM MT. Caller 15 will be qualified to win a Grand Prize. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the "CONTEST". Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

b. Fill in all required information. No more than one entry per person (or email address), per household, per day is permitted.

c. Entrant will be required to provide all information requested including Entrant's full name, complete address (including zip code), day and evening phone numbers, email address, and date of birth to be eligible to win. P.O. Boxes are not permitted as addresses.

2. ELIGIBILITY RESTRICTIONS

a. The "CONTEST" is open to all persons who are legal U.S. residents of the state of Utah, twenty-one (21) years of age or older, and who reside in one of the jurisdictions that make up the DMA listening area of Utah. Void where prohibited or restricted by law.

b. The following individuals are NOT eligible to enter the Station "CONTEST" at any time, even if such individuals meet the age and residency requirements above:

(i) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, "CONTEST" Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each.

(ii) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories.

(iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a "CONTEST" or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to entering the "CONTEST" are not eligible to participate. a. Five (5) Grand Prizes will be awarded. The Grand Prize consists of:

Any difference between stated ARV and actual value will not be awarded.

If applicable, the Winner may be required to present a valid credit card upon hotel check-in to cover any incidental expenses incurred during the Winner's stay. The Winner(s) and guest(s) must sign an IRS Form W-9, affidavit of acceptance, eligibility, liability, publicity release, and if applicable, "CONTEST" Sponsor liability release forms.

b. Federal, state and local taxes relating to the prize are the responsibility of the winner and station or sponsor will issue all tax forms, including a 1099 form to the winner. The Station reserves the right, in its sole discretion, to cancel or suspend the "CONTEST" should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the "CONTEST", or the Internet portion of the "CONTEST". Decisions of the Station and "CONTEST" Sponsor are final.

d. In no event will more than the stated number of prizes be awarded.

4. WINNER SELECTION AND NOTIFICATION

a. Decisions of the "CONTEST" Sponsor and Station management with respect to the "CONTEST" are final.

b. Four (4) of the Grand Prize Winner's will be selected on-air as described above in Section 1 of these Official Rules. One Grand Prize Winner will be randomly drawn from the online entries after the contest ends on January 26, 2025 and contacted by phone or email within 7 days. Entrant will be required to provide all information requested including full name, address (including zip code), phone number, email address, date of birth and social security number to be eligible to win. Winner must sign an Affidavit of Eligibility and Release within three business days thereafter. PO Boxes are not permitted as addresses.

c. One (1) entry per Entrant, per day, is permitted. There will be up to a total of five (5) Grand Prize winners selected in the "CONTEST" from all eligible entries received as outlined above.

e. On-Air Winners must listen to the Station to win but do not need to be present to win. All prizes will be emailed to the winner after appropriate winner forms are complete.

5. CONDITIONS

b. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the "CONTEST", including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the "CONTEST", any such material changes will be broadcast on the Station and/or posted on its website: <https://1035thearrow.com/> within twenty-four (24) hours of the change and periodically thereafter. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed, or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the "CONTEST" and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the "CONTEST" webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.

c. e. (vi) Any cancellations, delays, diversions, or substitutions or omissions by any transportation providers or any other persons or entities providing any services to Entrant(s) and/or Winner(s) (and Winner's guest(s) if applicable) including any results thereof such as changes in services or location necessitated by same. 6. PRIVACY

a. 7. COPY OF OFFICIAL RULES

a. Any violation of these rules will result in disqualification. Consistent with Section 1(b), only one entry per Entrant, per day is permitted. Any attempt by any one or more Entrants to obtain

more than one (1) entry by using the same phone number, email address, Twitter account or similar registration method through any means including, without limitation, multiple/different email addresses, Twitter accounts, identities, registrations, logins or other methods will void all entries from that address or account, and such Entrant(s) will be disqualified.
