  - iii. Five (5) unique Keyword's will be offered each weekday during the Entry Period to enter the contest. Listen at 7:10AM, 9:10AM, 11:10AM, 1:10PM and 3:10PM (MT) to enter up to five Keywords per day, per eligible person during the Entry Period, regardless if entrant has more than one email address. Keywords will only be available to enter online for two hours after each announcement. Ten (10) extra entries may be awarded for each friend who enters the contest if contest is shared on social media by Entrant. Multiple participants are not permitted to share the same email address or Facebook account. Entries submitted may not be acknowledged or returned.
