- a. These rules govern the KRSP THIRD EYE BLIND & UTAH STATE FAIR 4-PACK ON-AIR CONTEST ("Contest"), which is being conducted by KRSP ("Station"). The Contest begins on September 3, 2025 and ends on September 9, 2025 ("Entry Period"). Entrants may enter ON-AIR only.
  - i. To enter ON-AIR, listen weekdays during the 8-9am hours with Smith and Sam for the cue to call. When you hear it be the designated caller at 801-575-1035 to win a prize upon confirmation of eligibility. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth to be eligible to win. PO Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.
- b. Entrants are required to provide truthful information to the Station and will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

- b. The following individuals are NOT eligible to enter the Station Contest at any time, even if such individuals meet the age and residency requirements above:

- (i) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each.
- (ii) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories.
- (iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to the Contest are not eligible to participate. - b. Each Prize will consist of four (4) Utah State Fair Admission Tickets and four (4) tickets to Third Eye Blind at the Utah State Fair on Wednesday, September 10th. \*Fair tickets must be used on 9/10/25 to gain admission to the concert.
- c. All details of each Prize will be determined by the Station in their sole discretion. The Station reserves the right to substitute a similar Prize (or Prize element) of comparable or greater value. Prize cannot be transferred by Winner or redeemed for cash and is valid only for the items detailed above, with no substitution of Prize by Winner.

### 4. WINNER SELECTION AND NOTIFICATION

- a. Potential Winner(s) will be notified of winning at the time of entrant's call. The Prize will be awarded only upon confirmation of eligibility and completion of all requisite releases ("Winner Forms"). Upon notification or notification attempt, the potential Winner(s) will be required to respond to such notification attempt and must execute and return all winner forms within 24 hours of such notification or notification attempt or Prize will be forfeited. If a potential Winner(s) is deemed ineligible for any reason, cannot be contacted, fails to sign and return the fully executed winner forms within the required time period, or if the Prize notification is returned as undeliverable, the potential Winner forfeits the prize(s).
