Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. -Limit one (1) entry per eligible person per day on each station during the Entry Period regardless if entrant has more than one email address. Ten (10) extra entries may be awarded for each friend who enters the contest if contest is shared on Facebook by Entrant. Multiple participants are not permitted to share the same email address. P.O.
